Eligible residential land


Residential houses damaged by liquefaction from the Noto Peninsula Earthquake of 2024 and judged as having semi-partial damage or more on Disaster Victim Certificate ightharpoonup If the damage by liquefaction is deemed adequate, level of minor damage may also be eligible

Eligible construction

- ① Restoration work to restore damaged residential land to original state (retaining wall, ground, etc.)
- ② Improve house and building land to prevent subsidence
- 3 Works to repair settling and sloping foundation
- ※ Works underway or completed included

- ●Support percentage Up to two-thirds
- Maximum relief amount 7,666,000 yen

* If you use repair relief systems for damaged houses, etc., supported by the government, prefecture, or city, the amount is deducted.

Fixed assets & city planning taxes exemption for alternative housing purchased after disaster

There are special measures to exempt fixed assets and city planning taxes for houses acquired to replace houses * More information is posted on the Niigata City Website damaged by the Noto Peninsula Earthquake of 2024.

Requirements for damaged houses

Damage level is judged as partial damage or more by the City inspection and the damaged house has already been demolished or sold, etc.

Requirements for alternative houses

In principle, type (usage) or purpose should be the same as the damaged house and should be acquired by March 31, 2029

Contents of the special measures

For fixed assets & city planning taxes placed on alternative houses, the tax amount equivalent to the damaged house's floor area is reduced to half for four years from the year following the year it was acquired.

Examples

- · In cases where the damaged house was demolished and a new house was built in the same place or other places in the city
- In cases where the damaged house was sold and a previously owned house or condominium was bought, etc.
- X A similar special measure is applied in cases where depreciable assets have been replaced, improved, or repaired following loss or damage
